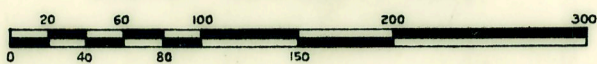


# ASSESSOR'S PLYMOUTH PLAT NO. 24

### DESCRIPTION

The land embraced in the annexed "Assessor's Plymouth Plat No. 24 of part of the E. 1/2 of Sections 26 and 35, T.1 S., R.8 E., City of Plymouth, Wayne Co., Michigan." is described as follows: Beginning at the S. 1/4 Cor. of Sec. 26, T.1 S., R.8 E. and proceeding thence along the N. & S. 1/4 line of Sec. 26, N 2°24'51"W, 1237.05 ft.; thence along the South boundary of Assessor's Plymouth Plat No. 18, N 87°43'37"E, 717.05 ft.; thence S 1°24'51"E, 997.27 ft.; thence along the center line of Ann Arbor Trail, N 65°25'21"W, 50.00 ft.; thence along the West boundary of Eastlawn Subdivision, S 2°32'47"E, 386.26 ft., S 3°52'36"E, 516.75 ft., and S 4°26'06"E, 48.48 ft.; thence S 88°00'17"W, 187.49 ft.; thence S 88°25'05"W, 486.56 ft.; thence along the N. & S. 1/4 line of Sec. 35, N 2°09'09"W, 682.00 ft. to the point of beginning.

### SURVEYOR'S CERTIFICATE
