Description:

The land embraced in the annexed plat is described as follows:-
 Beginning at an iron stake in the center line of Mill St. said center line is the N & S line of Sect. 26 T.15. R.8E. Plymouth Village, Wayne Co. Mich. S.0°-18' W. 231.07 ft. From the intersection of said center line and the center line of the Plymouth Road, S.0 called; thence S.86°-08'E, 507.70 ft. to an iron stake; thence S.1°-42' W. 353.2 ft. to an iron stake in the Northernly line of the Park Subdivision No. 1; thence N. 85°-21' W. 315.4 ft. along said Northernly line to an iron stake; thence N. 0°-18'E. 249.6 ft. parallel to said center line of Mill St. to an iron stake; thence N. 85°-21' W. 183.4 ft. to an iron stake in the center line of Mill St.; thence N. 0°-18'E. 104.20 ft. to the Point of Beginning.

This plat was approved by the Commission on the 17th day of Dec. 1922, and is hereby held in force by the Clerk.

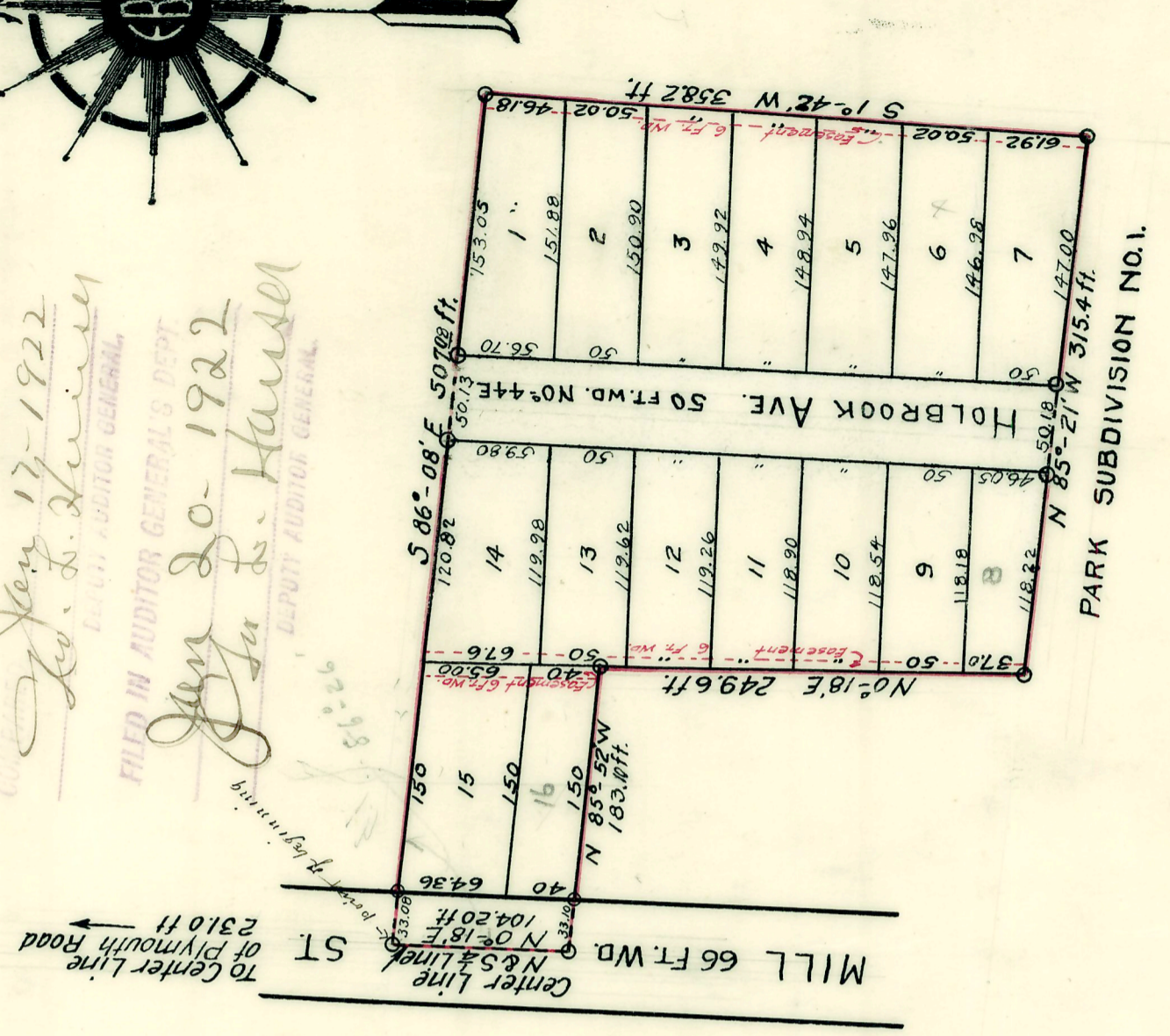
