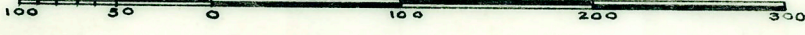


# "PARK SUBDIVISION"

**DESCRIPTION:**

The land embraced in the annexed plat is described as follows:  
Beginning at the Center Post of Sect 26, T. 15, R. 8. E. Plymouth Village, Wayne Co. Mich. thence N. 0° 18' E. 24.00 ft. along the N. & S. 1/4 line of said Sect 26 and center line of Mill St to an iron stake; thence S. 89° 17' E. 103.0 ft. parallel to the E. & W. 1/4 line of said Sect. 26 to an iron stake; thence N. 0° 18' E. 539.90 ft. to an iron stake; thence S. 85° 21' E. 315.40 ft. to an iron stake; thence S. 1° 21' W. 542.30 ft. to an iron stake in the E. & W. 1/4 line of said Sect. 26; thence N. 89° 17' W. 487.14 ft. along said E. & W. 1/4 line to the Point of Beginning.

I hereby certify that the plat hereon delineated is a correct one and that permanent monuments, consisting of one inch gas pipe, 10 inches long, have been planted at points marked thus. (Symbol) as thereon shown at all angles in the boundaries of the land platted, and at all intersections of streets or streets and alleys.

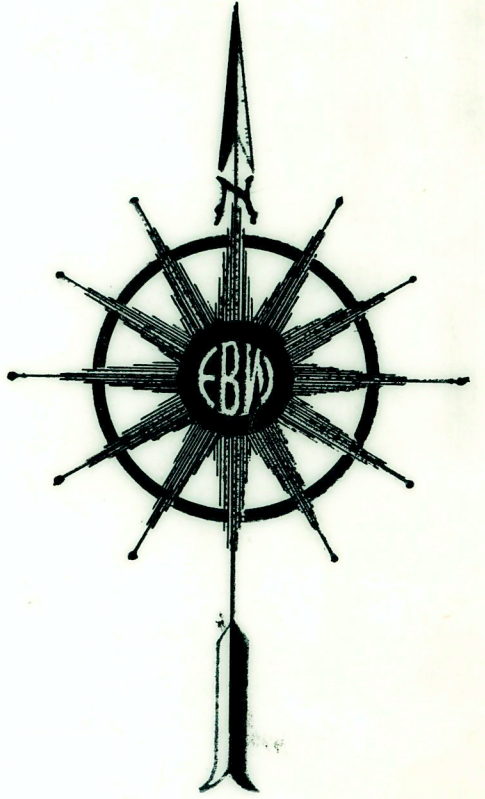
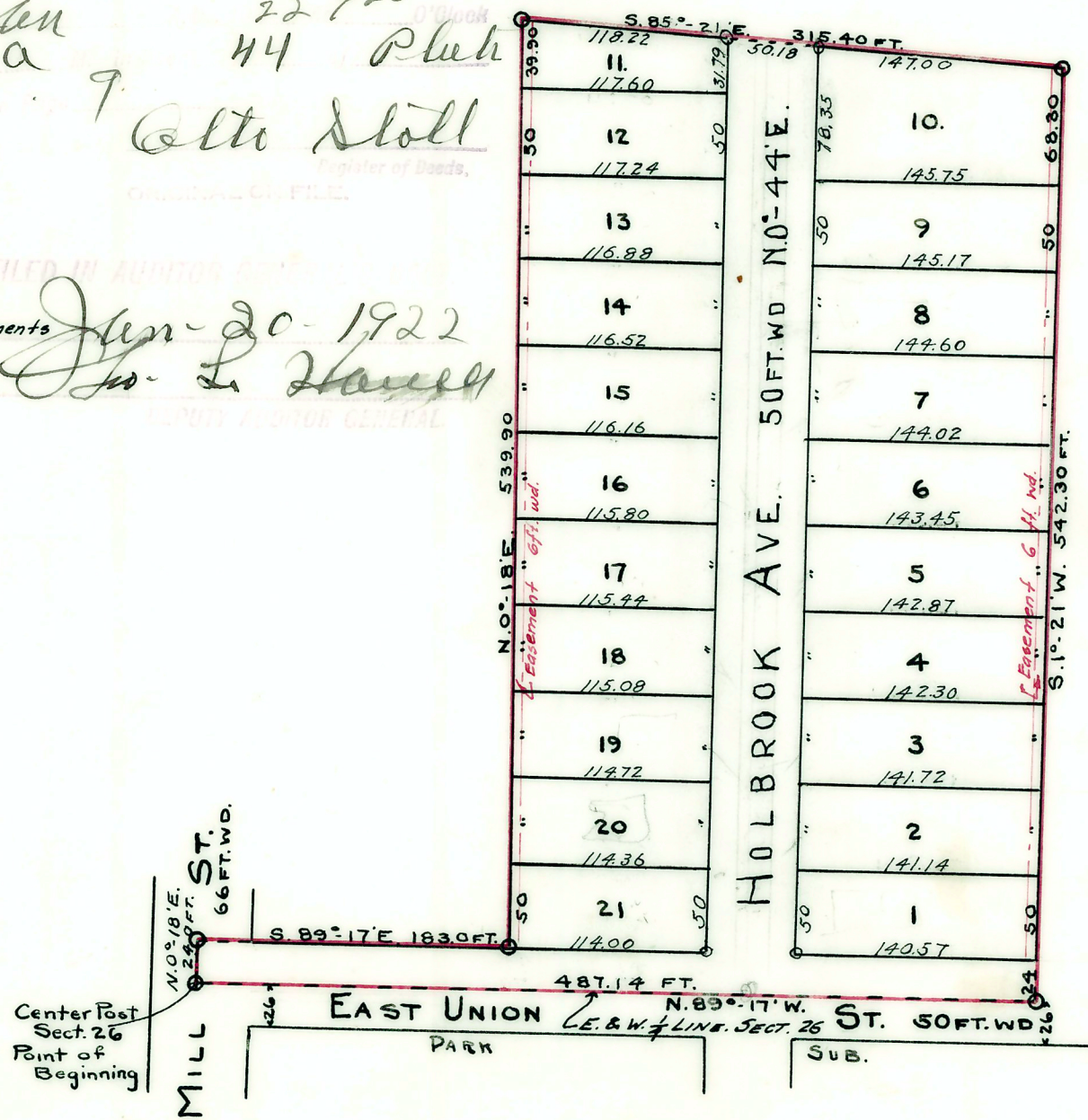
