

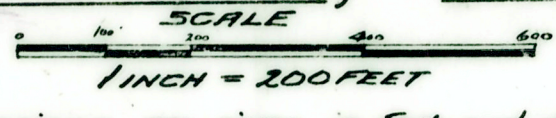

All dimensions are given in feet and decimals thereof.

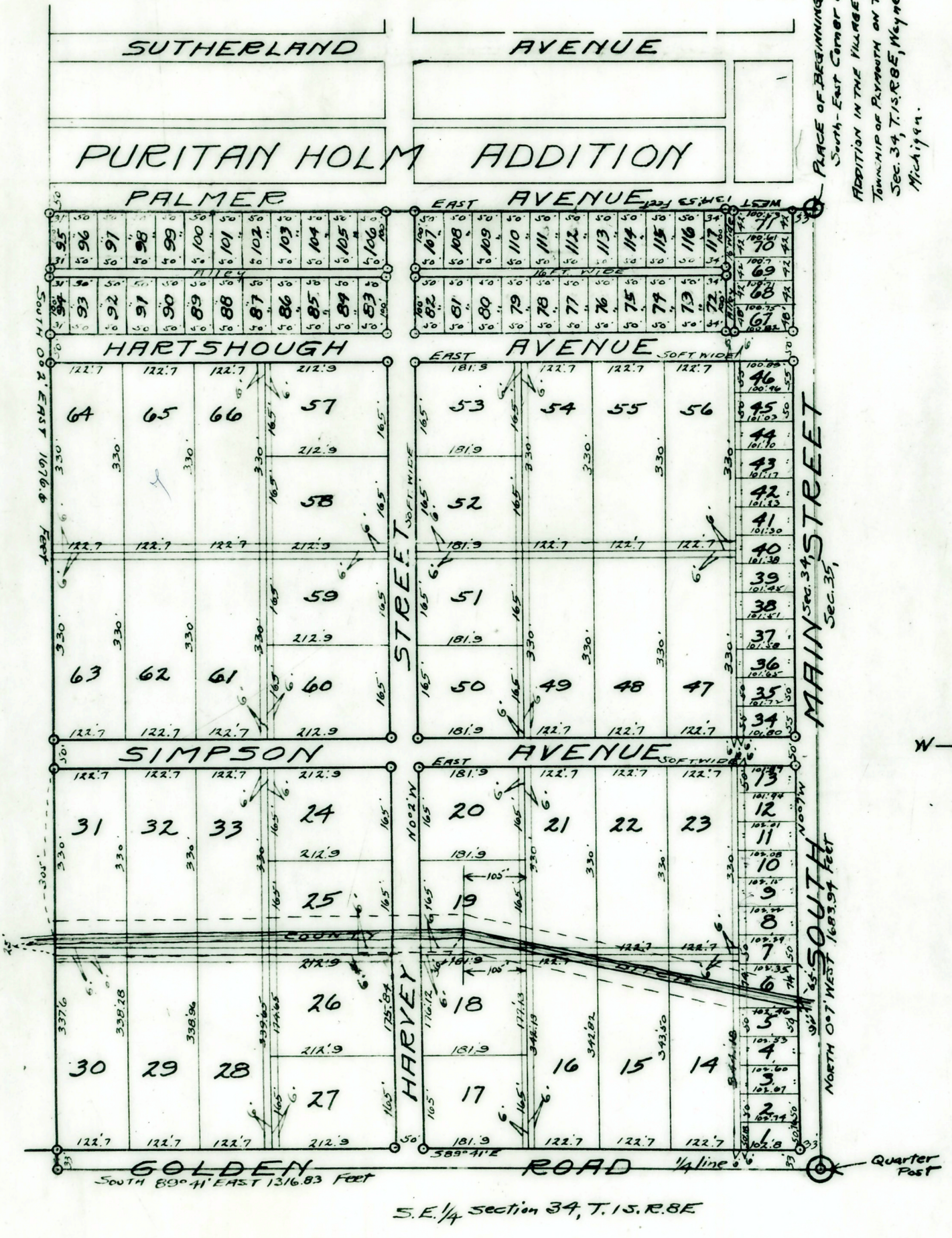
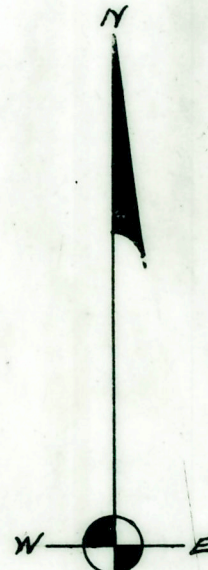

North 007' West 1683.94 Feet to place of beginning. Being on
the N.E. 1/4 of Section 34, T.15. R.8E., Wayne County, Michigan.
