

The land embraced in the annexed plat is described as follows: beginning at a point N. 0°06'41" W. 33 ft. and  
 N. 89°40'50" W. 135.80 ft. from the E. 1/4 post of section 34. T.15.R.8 E. said point being the S. E. corner of lot 14 of  
 plat of Sunshine Acres Sub. of part of N.E. 1/4 of said section 34 and running thence along the N. line of Golden Rd.  
 N. 89°40'50" W. 1181.00 ft. to a point; thence along the W. line of lots 30, 31, 63 and 64 of said Sunshine Acres Sub.  
 N. 0°02'00" W. 1377.60 ft. to a point; thence along the S. line of Hartshogh Ave. East, 631.00 ft. to a point; thence S. 0°06'41" E. 50.00 ft. to a  
 point; thence West, 115.48 ft. to a point; thence S. 0°02'00" E. 655.00 ft. to a point; thence West, 116.38 ft. to a  
 point; thence along the W. line of South Main St. S. 0°06'41" E. 274.00 ft. to a point; thence West, 102.66 ft. to  
 a point; thence S. 0°02'00" E. 100.19 ft. to the point of beginning.
