Meeting Minutes Monday, January 6, 2025 - 4:00 p.m. Plymouth City Hall – 201 S. Main, Plymouth

1. ROLL CALL

PRESENT: Chair Brian Turnbull, Members Commissioner Linda Filipczak, George Lahanas, Jim Rachwal, Paul Sincock.

a. Also present was Plymouth Public Safety Director Al Cox

2. APPROVAL OF MEETING MINUTES OF OCTOBER 21, 2024

Moved by Sincock and seconded by Rachwal. No comments. MOTION PASSED

3. REVIEW OF FINANCIAL REPORTS FROM THE CITY OF NORTHVILLE

Reports show that the budget is less than 50% expended, six months into the fiscal year.

4. OTHER MATTERS FOR REVIEW BY THE NPFAB

Fire Chief Matt Samhat distributed a number of reports to the Board at the meeting.

- a. Fire Inspections the report showed over two hundred new fire inspections in 2024. The chief indicated that he is increasing the number of inspectors to hopefully cover more inspections, especially in Northville. Member Filipczak asked for some year-to-year information to make a comparison of our activity.
- b. Training The Chief's report indicated a nearly equal number of training hours for both stations of just over 1,000 hours. The biggest number of training hours is a result of the Thursday night sessions.
- c. Staffing Report It was reported that Station 1 has 22 members listed at that station and Station 2 has 23 members assigned to that station. Between the two stations there are a total of 20 members who respond to calls at a rate higher than 20%. There are 21 members between the two stations that respond at a rate of less than 10%. Station staffing has made a difference in response times and both stations have average emergency response times of less than six minutes from the time of call to dispatch to arrival of the first unit on scene.
- d. Station Run Volume nearly 2,000 calls for service were reported between the two stations.
 Plymouth had 59.7% of the total runs with 1,160 calls for service. Northville has 40.3% of the run volume for the year with 783 calls.
- e. Mutual Aid The Chief explained that the Department provides more Mutual Aid than it receives, simply because we are two small cities. The Department received a total of seven mutual aids in 2024, while providing mutual aid to other communities a total of eighty-four times. Northville Township received the most mutual aid, followed by Plymouth Township.



Funds have been set aside for a replacement aerial truck each year. Since the truck was sold to Northville Township, those funds are no longer needed. There is \$300,000 that I would propose using to offset future contributions by both communities over the next 5 years. I would propose leaving some of it in contingency just in case something new comes up or equipment is higher than expected. Then I would propose that we reduce the annual contributions required by \$50,000 each year for 5 years. Depending upon the share each year, that would lower the City's contribution by approximately \$20K each year and Plymouth by \$30K each year. I would propose that it begin with FY26.

I am requesting that this be a topic of discussion at the next NPFAB meeting.
